#### EARLY ORGANIZATION AND STATE CHAPTER OF NRA

- First Organized in 1944 -G.A. Kamiske, 1st President
- Became First State Chapter of the NRA in 1949
- Early leaders included Ralf Peckham, Jean Hansen Ockerman, H.A Davidson
- Members in the 50's -70's came from wide array of rehab and disability organizations: Rehab Facilities, Health care and equipment, vocational schools,VR, Disability Determination Services, Higher Ed
- Incorporated as a Michigan Non-Profit in 1977 as "MRA"



# MRA CONSTITUTION-PURPOSES REVISED NOV. 1993

Within the meaning of Section 501(c)(3) of the IRS

- Promote and advance professional rehab services leading to full inclusion and maximum independence of PWD in all life activities.
- Promote, support, and provide leadership in advancing rehab professions.
- To work and cooperate with agencies, disciplines, orgs and people dedicated to independence equal access, integration, and employment of PWD.
- To inform and provide information to public officials re. benefits and programs that lead to equal access, independence and employment for PWD.
- To buy, sell or hold property and engage in contracts.
